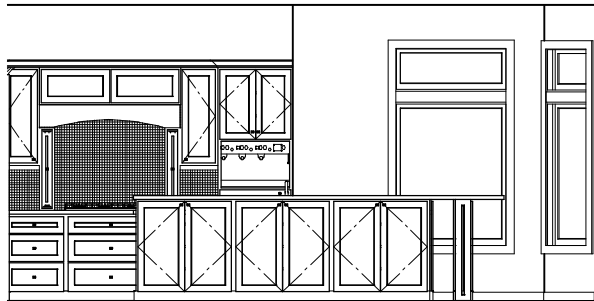

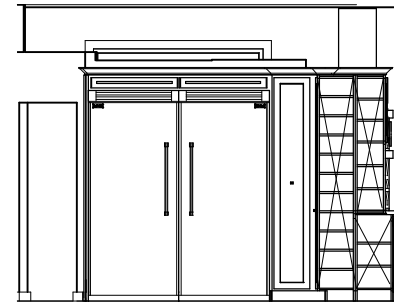
**A** Kitchen - North Wall



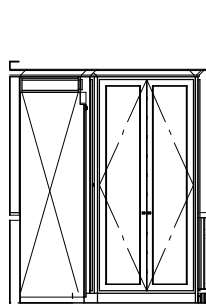
**B** Kitchen - Island Front



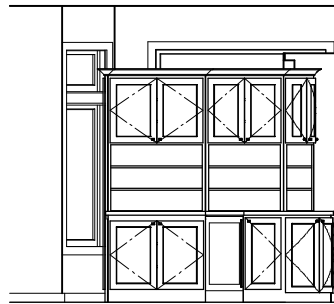

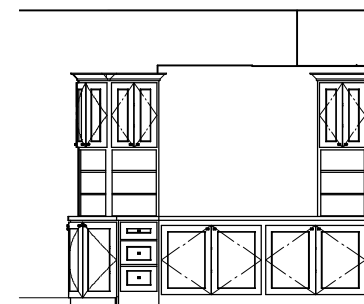

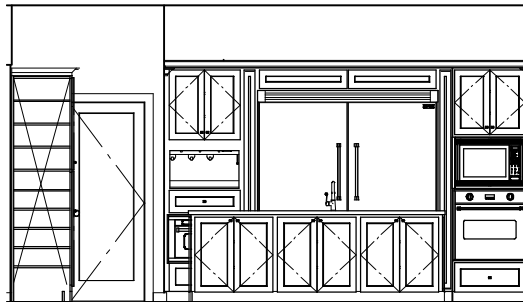

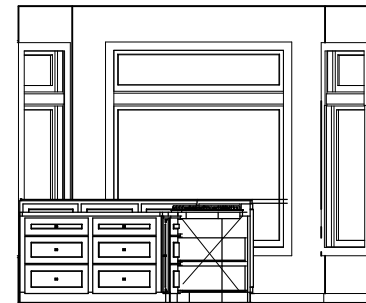
H Kitchen - North Wall



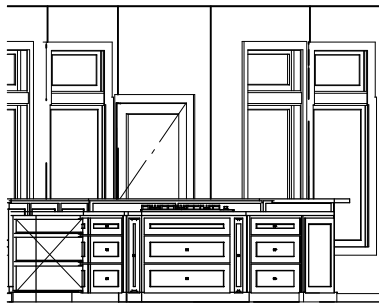
I Kitchen - Island Front



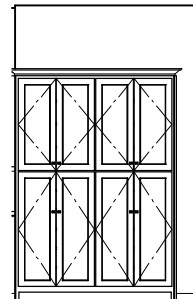
J Kitchen - Island Back



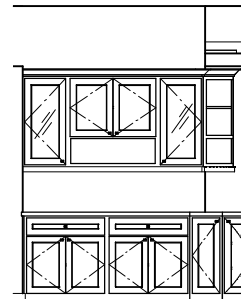
K Kitchen - Peninsula Front - 1



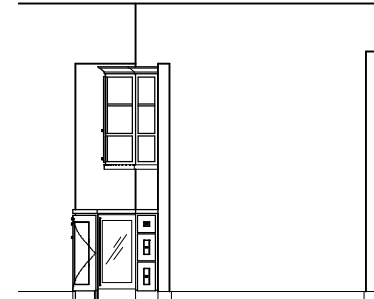

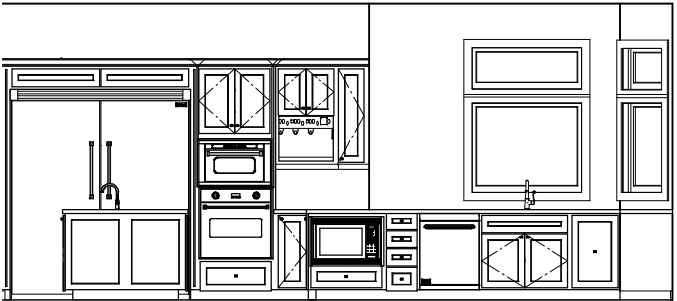

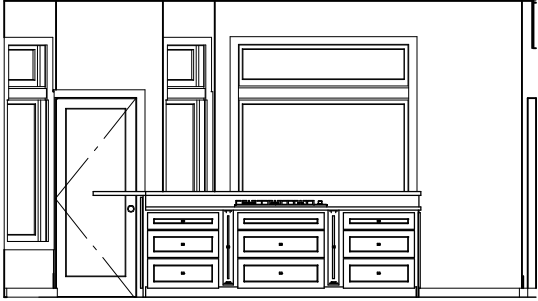
**P** Kitchen - North Wall



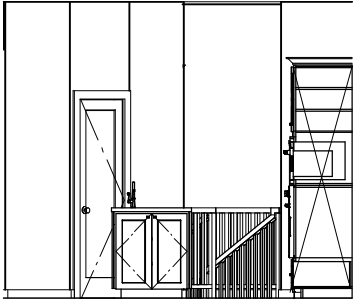
**Q** Kitchen - Short East Wall



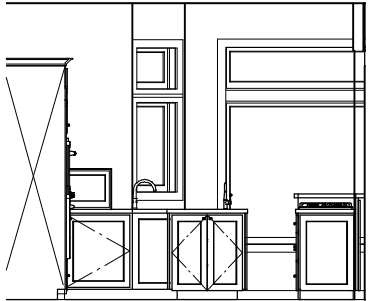
**R** Kitchen - North Wall (wide view)

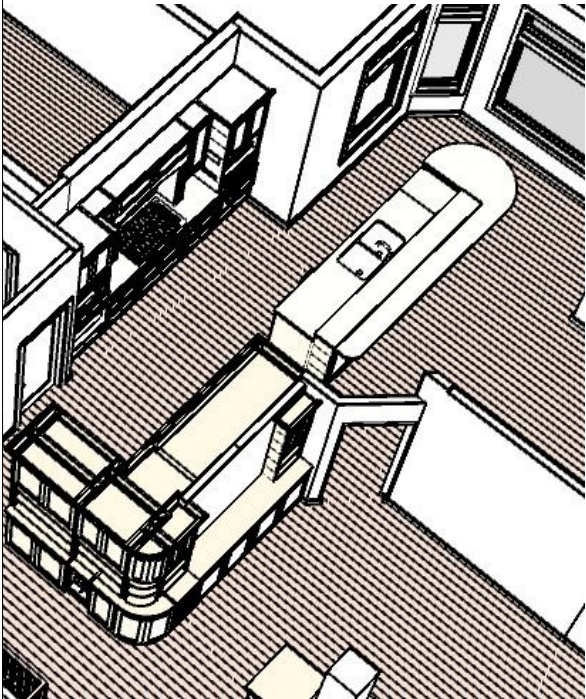

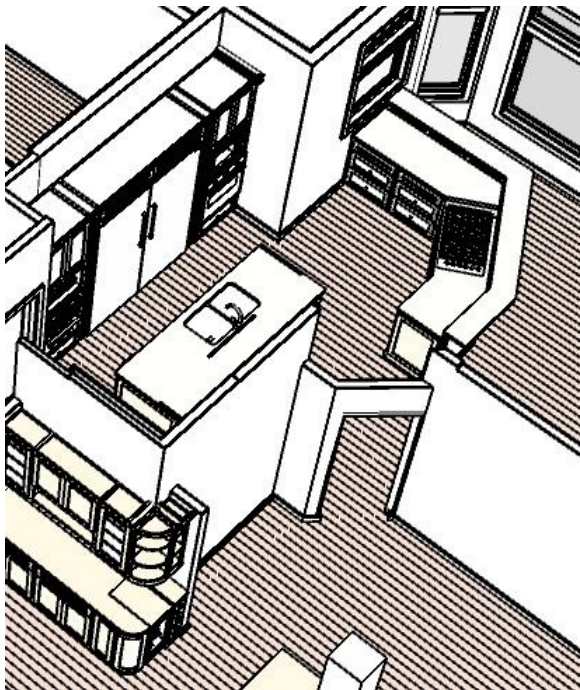

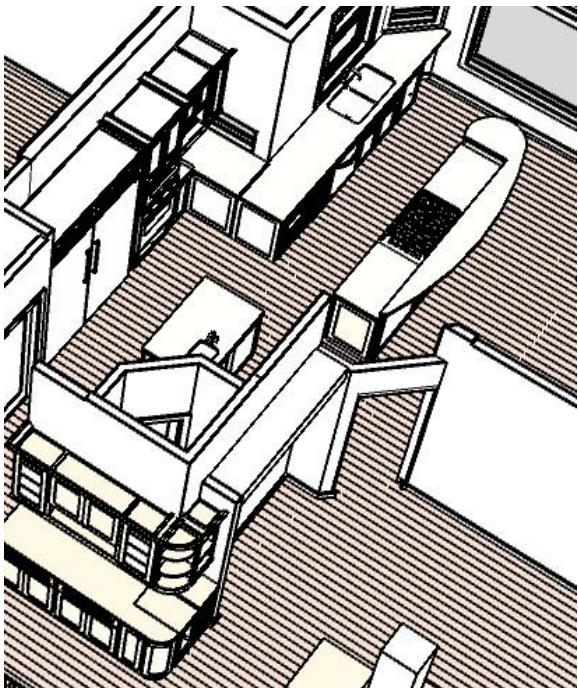
